

LICENSE GRANT TO THE BOARD OF REGENTS OF THE UNIVERSITY OF OKLAHOMA

1. Definitions

"Adaptation" means a work based upon the Work, or upon the Work and other pre-existing works, such as a translation, adaptation, derivative work, arrangement of music or other alterations of a literary or artistic work, or phonogram or performance and includes cinematographic adaptations or any other form in which the Work may be recast, transformed, or adapted including in any form recognizably derived from the original, except that a work that constitutes a Collection will not be considered an Adaptation for the purpose of this License. For the avoidance of doubt, where the Work is a musical work, performance or phonogram, the synchronization of the Work in timed-relation with a moving image ("synching") will be considered an Adaptation for the purpose of this License.

"Collection" means a collection of literary or artistic works, such as encyclopedias and anthologies, or performances, phonograms or broadcasts, or other works or subject matter that, by reason of the selection and arrangement of their contents, constitute intellectual creations, in which the Work is included in its entirety along with one or more other contributions, each constituting separate and independent works in themselves, which together are assembled into a collective whole. A work that constitutes a Collection will not be considered an Adaptation (as defined above) for the purposes of this License.

"Distribute" means to make available to the public the original and copies of the Work, Adaptation, or Collection, as appropriate, through sale or other transfer of ownership.

"Author" means, in the case of a literary or artistic work, the individual who created the Work or if no individual or entity can be identified, the publisher.

"Reproduce" means to make copies of the Work by any means including without limitation by sound or visual recordings and the right of fixation and reproducing fixations of the Work, including storage of a protected performance or phonogram in digital form or other electronic medium.

"Work" refers the work offered under the terms of this License, whatever may be the mode or form of its expression.

2. License Grant

For good and valuable consideration, including but not limited to publicity, the adequacy of which is hereby acknowledged, Author hereby grants CSRDE a worldwide, royalty-free, exclusive, and perpetual license to exercise the rights in the Work stated below:

- a. to Reproduce the Work, to incorporate the Work into one or more Collections, and to Reproduce the Work as incorporated in the Collections;

- b. to create and Reproduce Adaptations;
- c. to Distribute and Publicly Perform the Work including as incorporated in Collections; and,
- d. to Distribute and Publicly Perform Adaptations.

Except as provided in this License, Author shall retain all rights to the Work.

3. General Terms

Upon distribution of the Work or any Adaptation or Collection utilizing the Work, CSRDE will provide, in a manner it determines in its sole discretion is reasonable to the medium, the name of the Author, the Author's institutional affiliation, and the title of the Work.

Author represents and warrants to CSRDE that the Work is the original work of the author and has never been published. Author further represents and warrants to CSRDE that Author is the owner of all the rights in the Works.

The term of this License shall be for the duration of the term of the copyright protection.
